## Scale of Fees – 2009

Fees for students in Kindergarten to Year 11 are charged four times per year with Fee Accounts being issued at the beginning of each term. Fees for students in Year 12 are charged three times per year at the beginning of Terms 1, 2 and 3. The following schedule indicates the amount payable per term and the annual figure is also given. **A discount will be given to those whose payment is received on or before the due date each term.**

# Scale of Fees - 2009

## Payment by Due Date

The early payment discount is only available if payment is received in full by the due date.

## Payment Methods

Payment can be made by credit card on-line ([www.stcaths.nsw.edu.au](http://www.stcaths.nsw.edu.au)), by credit card using our telephone service (1 300 364 298), by cheque, BPAY, EFT, or direct debit (please contact the Accounts Office to make arrangements). Credit cards accepted are Visa, MasterCard, and American Express.

Please note that the merchant fee charged by credit card providers will be passed on.

Please also note that cash will not be accepted for the payment of tuition fees.

## Overdue Accounts

If the school fees are received by the due date a \$50 discount is provided. Reminder notices are sent out two weeks after the due date and second reminder notices are sent out two weeks after the initial reminder:

In each case, if a reminder notice is required to be sent out an additional \$50 administration charge will be added to the account.

If fees remain unpaid after the second reminder notice, interest will be charged at a rate of 10% per annum on the outstanding amount, interest accruing from issuance date of second reminder.

## Sister's Discount

Second and subsequent sisters receive a 10% discount on Tuition Fees only. Where a student is eligible for more than one discount, the student will receive the larger of the two discounts, and the discounts will not be cumulative.

## Notice of Withdrawal

One full term's notice is required in writing before the withdrawal of a student. In lieu of one term's notice, a term's fees will be charged. This applies to Tuition Fees and Boarding Fees. This notice forms part of the contract between parent and St Catherine's School, as specified in the School's Statement of Conditions of Entry.

## Camp Costs

There are scheduled camps managed by external providers for Years 4 through 11 inclusive. Although the camps are compulsory, the costs are charged separately, in addition to tuition fees.

Camp costs for Years 4, 5 and 6 are billed to Term 2 accounts only.

Camp costs for Years 7, 8, 9 and 10 are billed over Terms 1, 2 and 3.

The Year 11 Retreat is billed to the Term 4 account.

## Co-Curricular Subjects

Co-curricular subjects are available and are charged on a per term basis. A separate booklet and scale of fees for Co-curricular subjects is sent to parents prior to the end of each school year. Enrolments and withdrawals of Co-curricular subjects must be made a minimum of three weeks prior to the end of each term. (Please see Co-curricular Tuition Sheet for more details).

## Building Fund

All parents are encouraged to contribute to St Catherine's Building Fund in the form of tax deductible donations. An amount of \$100 appears on each Statement of Account as a suggested voluntary donation from each family.
